
INTRODUCTION

CLOUD MANAGEMENT

- 1. Sign up at console.plasma-cloud.com.
- Create your first organisation by navigating to Organisations → Create new organisation. Fill in the form and click Create.
- You can now create your first network. Navigate to Networks → Create new network, fill in the form and click Create.
- Setup your network by navigating to Settings → Network.
- 5. Go back to Overview and click on the map to add your first Switch.

The last point can be repeated to add as many Switches as needed.

You can now plug-in your Switch and connect it to the Internet. The Plasma Cloud configuration only takes a few seconds!


PHYSICAL INSTALLATION

The PSX8 Switch offers versatile mounting options, allowing installation on a desk, wall, or rack. It is intended for indoor use only.

When installing your Switch, keep the following in mind:

- Do not place heavy objects on the Switch.
- Don't place the Switch in direct sunlight and ensure there is sufficient space around the vents.
- Don't place the Switch next to a strong source of electromagnetic field.
- Ensure the power cord is properly plugged into the Switch and a power outlet with earthing connection, or equivalent.



DESK OR SHELF MOUNTING

This Switch can be placed on a desk or a shelf:

- 1 Stick the provided rubber feet to the four marks on the bottom of the Switch.
- 2 Place the Switch on the desk or the shelf, making sure the surface is levelled.




WALL MOUNTING

This Switch can be mounted either vertically or horizontally to a wall:

1 Attach the two mounting brackets to the sides of the Switch using the provided screws, as shown below.




2 Secure the mounting brackets to the wall using the provided screws and anchors, with the switch ports facing upward or sideways.




RACK MOUNTING

This Switch can be mounted in an EIA standard size (19") rack.

Attach the two mounting brackets to the side of the Switch with the screws provided as shown below.



Secure the mounting brackets to the rack using the provided screws, with the Switch ports facing forward.
